Over 50 years ago, GLSP began to take shape when a group of younger lawyers from the State Bar of Georgia began studying the "disproportion between the need for legal services by those who cannot afford them and the present supply of legal services available to them." They found that lawyers tend to concentrate in urban areas whereas many of Georgia's poor lived in rural areas where legal help was less available. In 1971, the Younger Lawyers Section incorporated the Georgia Legal Services Program "to provide legal services to indigent persons to the fullest extent possible."

To commemorate our 50th anniversary, we are delighted to announce our upcoming events to celebrate this momentous occasion.

On Friday, September 17, 2021, Georgia Legal Services Program will host the Rural Georgia Justice and Poverty Summit at the Georgia State University College of Law's Center for Access to Justice. ## Why did you choose to work for GLSP?

My work at Georgia Legal Services Program began in October 1998. I was hired by Phyllis Holmen, Executive Director; Robert Davis, Associate Director, and Jack Webb, the Director of Finance. I was interviewed by all of them. I saw the job advertisement in the newspaper, and I applied. I had heard of Atlanta Legal Aid, but not

Georgia Legal Services. After researching, I was eager to learn more how this organization served the under-served population.

#### How has GLSP evolved over the years?

GLSP continues to be innovative in technology efforts and diversify our portfolio of cases that our attorneys handle.

Throughout the years, GLSP and our clients have been faced with several disasters: from floods and tornadoes, to more recently, racial tensions and a health pandemic. GLSP has maneuvered to protect its employees and to continue to provide support to individuals in most need of legal assistance. Overnight our world was upended by COVID-19, which affected our service delivery, and our ability to meet with clients, while ensuring the health and safety of our employees. Our staff quickly adapted to the needs of our clients by representing clients in court by video and hosting virtual community education sessions. As we move forward, GLSP will continue to fulfill our mission to provide civil legal services for persons with low incomes, creating equal access to justice and opportunities out of poverty and meet the most critical needs of our clients.

#### Inspire

Our clients motivate us to keep striving to fulfill our mission. Our client victories inspire us to hope for success and a better future.

Anthony\* and his mother were referred to our office through the Autism and Developmental Center. He is in elementary school and has Autism and some behavior issues. Anthony's mother was frustrated with the school because the staff was not challenging her son enough academically, and they would call her to come to pick him up after every outburst or problem. The mother was also concerned that her son was not receiving enough supervision and that he was not receiving all of the therapy he was entitled to under his Individualized Education Plan (IEP).

Our medical legal partnership attorney advocated for Anthony at his IEP meeting and successfully helped him receive a one-on-one aide. Anthony's aide will ride the bus with him to and from school, be by his side throughout the entire school day, and will work on coping techniques and diversion tactics to help curb the behavioral issues. We also set new academic goals that the mother felt more accurately reflect her son's capabilities and reaffirmed the therapies that Anthony will receive through his IEP.
